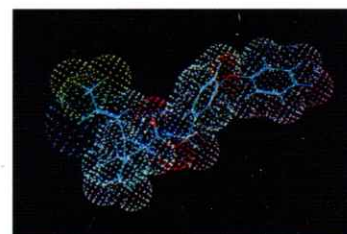

Mosquito : *Aedes, Culex & Mansonia* spp.

Dengue, dengue haemorrhagic fever (DHF), malaria, yellow fever and filariasis are some of the diseases transmitted by the mosquito. Dengue is on the rise in many countries due largely to urbanisation.

Apart from chemical control, other measures can be taken to reduce and destroy mosquito breeding grounds e.g. cleaning of compound; removal of empty tins, bottles; covering of water storage tanks; check drains, rain gutters to ensure that they are not clogged etc.



Cockroaches : *Blattella germanica & Periplaneta americana*

Cockroaches can be found in drains, sewage systems, kitchen area, store rooms, hotel rooms, toilets and other unhygienic places where there is food and moisture.

They carry salmonella, other harmful disease organisms and pathogen which can aggravate symptoms of asthma in children. They leave dirty stains and an awful smell in drawers, closets and cabinets.

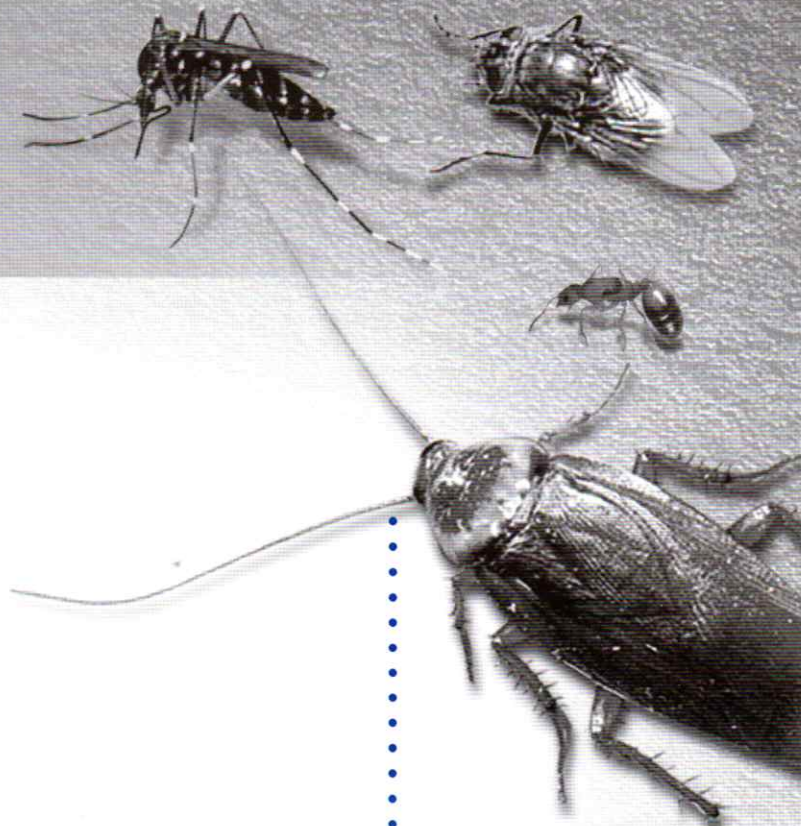


Houseflies : *Musca domestical*

Houseflies can be a major cause for concern in public health. Restaurants, eateries and public places may have problems with houseflies if they are not kept clean.

Houseflies are responsible for spreading diarrhoea, dysentery, food poisoning and they contaminate food.
